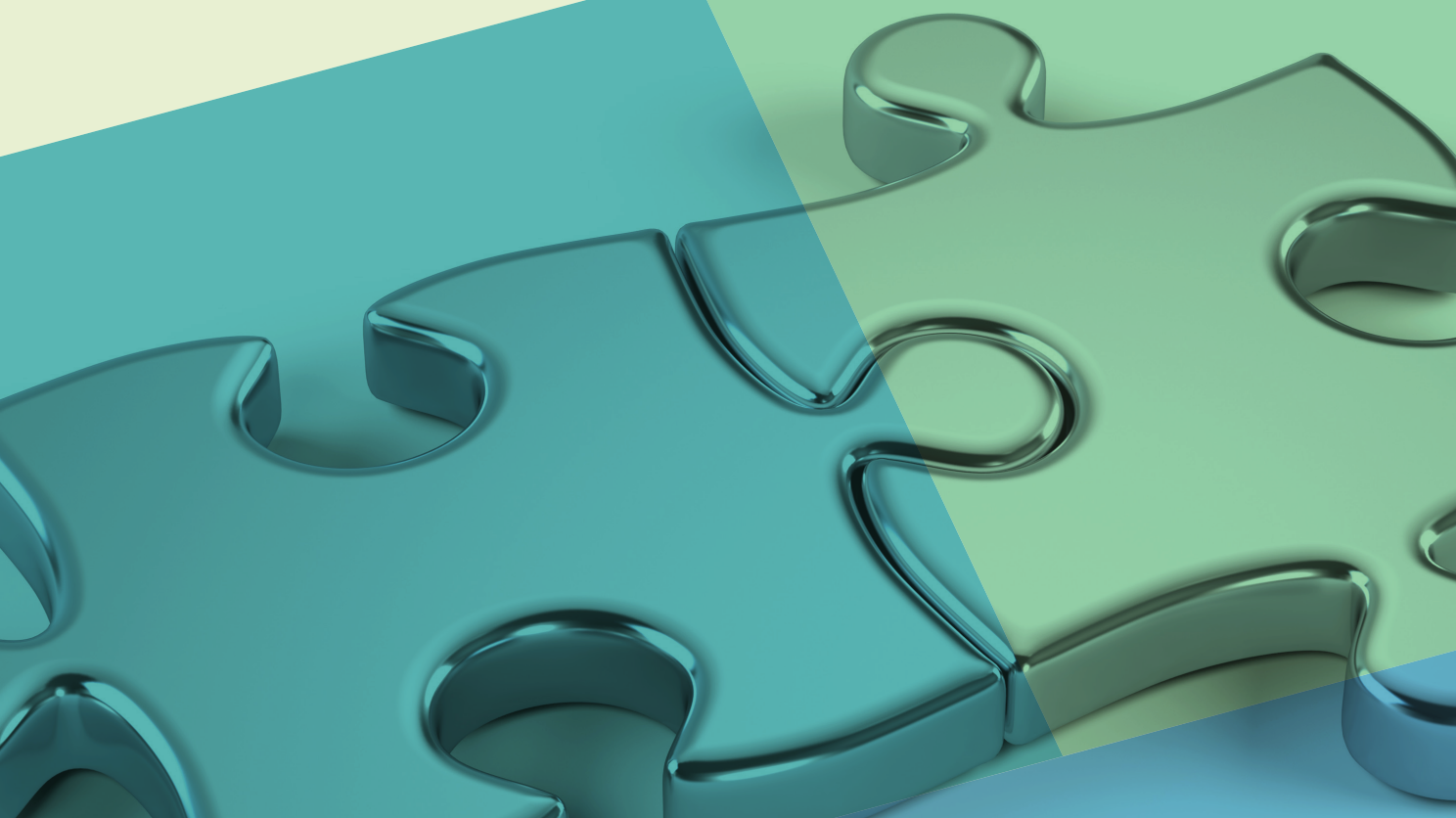

Dexcom, Inc. manufactures Real-Time continuous glucose monitoring (RT-CGM). This advanced glucose monitoring technology measures interstitial glucose levels and displays the current blood glucose level and direction and rate of change. This complete picture of glycemic activity helps guide disease management decisions (e.g., insulin dosage adjustments, changes in diet) to avoid glycemic excursions. For patients with hypoglycemia unawareness, the alarm function of RT-CGM devices may be their only warning of emerging hypoglycemia. The Dexcom RT-CGM is indicated for adults and children ages 2 years of age and older. The Dexcom RT-CGM is a covered benefit for nearly all commercial payors in the US. Medicare provides coverage for intensively managed insulin taking Type 1 and Type 2 patients, and a majority of state Medicaid programs cover for CGM.
