

Campaign Update

March 2025 Edition

On Oct. 23, 2024, the Advisory Committee on Immunization Practices (ACIP) amended their pneumococcal conjugate vaccine (PCV) single-dose recommendation to include all PCV-naïve adults aged 50+. The risk-based recommendation for adults aged 19–49 remains unchanged. As outlined in the Jan. 9, 2025 issue of the Center for Disease Control and Prevention's (CDC's) Morbidity and Mortality Weekly Report (MMWR), the rationale behind this decision includes the high prevalence of risk conditions among adults 50–64, as well as ongoing racial disparities in pneumococcal disease incidence and vaccination coverage in this age group. This updated recommendation is intended to improve pneumococcal disease prevention among this age group, especially for demographic groups experiencing higher disease rates.

The Rise to Immunize™ (RIZE) campaign will update the age group of the campaign's pneumococcal and bundle measures to 50+ to align with ACIP's recommendation changes. These measure changes will be effective July 1, 2025 (Q3 2025, report due Oct. 15, 2025).

The RIZE team will provide updated Measurement Specifications and an updated Data Reporting Excel Template prior to the change. This change will *not* affect any of the submissions for the Reporting Quarters Q1 2025 (submitted Apr. 15, 2025) and Q2 2025 (submitted July 15, 2025).
