- Organizing and executing community events to enhance health screening rates
- Assess your organization's data collection capabilities for race, ethnicity, language, and SDOH and identify areas for improvement.
- Provide cultural awareness training for staff
- Ensuring diverse representation within your team
- Providing increased support for patients facing significant barriers
- Forge partnerships with community organizations that tackle SDOH, such as financial security, education, food security, housing, and transportation
- Participating in one of AMGA's programs (research, AMGA Foundation, etc.)
- Presenting at an AMGA meeting/educational webinar or other health equity-related meetings or events
